As a result of successfully qualifying all stages of examination conducted by the Staff Selection and completion of the recruitment process, you have been allotted for enlistment in CRPF. Accordingly you are provisionally selected for the appointment as Constable (General Duty) in CRPF. The post is purely temporary but likely to continue.


02. The Pay scale of Constable (General Duty) as per 7th CPC lies in the Pay matrix-3 and is Rs. 21, 700/- as on date. In addition to this, you will be entitled to Dearness Allowance, Ration Money, Washing Allowance and other allowances as entitled to the Central Government employees from time to time and other allowances/ benefits as admissible to the CRPF personnel.

03. The terms and conditions of appointment are as under :-

- a) The post is combatised and purely temporary but likely to continue. On appointment to the post, you will be on probation for a period of two years. On successful completion of the period of probation, you will be considered for confirmation. Your services are liable to be terminated at any time by the appointing authority without assigning any reasons, on one month's notice during the initial period of 02 years in accordance with the Central Civil Services (Temporary Service) Rule 1965.
- b) The appointment carries with it the liability to serve anywhere in India or outside of India.
- c) On joining this organization you will be governed under CRPF Act 1949 read with CRPF Rules 1955 and other recruitment rules notified/ amended from time to time. This joining will be regulated from the date of your joining CRPF. You have to follow rules, orders and other instructions related to service conditions issued by the department from time to time.
- d) You will be required to undergo basic training at any of the Training Institutions of CRPF. If you are not able to undergo / complete the training successfully, your service is liable to be terminated.
- e) You are at liberty to resign from the post before completion of 10 years service provided a sum equal to three months pay and allowances or cost of training imparted to you by the Force, whichever will be higher, is refunded to the Government. However, the appointing authority is fully competent to accept or reject request for Discharge/ Resignation from service on merits.
- f) On joining the post offered you must meet to the eligibility conditions and be suitable for the post in all respects under provision of the relevant recruitment rules.
- g) The CRPF has no liability in case of any injury incident / accident occurred during the transit/ journey period for joining the Force.
- h) On appointment to the said post you will have to undergo basic training of specific period. In case you sustain any injury during the period of basic training and you are declared as permanent incapacitated for service in CRPF, your service will be liable to be terminated at any time without notice. It will be dealt according to CCS(Temporary) Service Rules.
- i) Authenticity of the Character and Antecedent, Education/ DOB/ Caste Certificate produced by you shall be verified from the concerned issuing authority. In case of any discrepancy found or malpractice noticed at any stage of Examination, your services shall be liable to be terminated. You shall also be liable for action against you as per law.



MEMORANDUM

The undersigned hereby offers Shri Smt. Kmt Hemkala Son / D/O Shri Bharat Das a post of Constable (General Duty) in the minimum pay of Rs. 21700-49100. (in the Pay Matrix (Level 3) in Sashastra Seema Bal. He/She will also be entitled to draw other allowances, at the rates as admissible to Central Govt. employees, subject to the conditions as laid down in the rules and orders governing the grant of such allowances in the Force from time to time.

2. The terms and conditions of appointment are as follows:-

i) On joining the Force, he/she will be governed by the Sashastra Seema Bal Act 2007 & Rules 2009, manuals & other rules/orders as issued and amended from time to time by the Government.

ii) The appointment is purely temporary but likely to continue. He/She will be on probation for a period of 02 (Two) years from the date of appointment. The competent authority, as prescribed under SSB Rules may, for the reasons to be recorded in writing, extend the period of probation for such further period or periods not exceeding two years or may during the period of probation, terminate his/her services without assigning reasons. His/Her permanent appointment to the post, however, will depend upon various factors governing terms of permanent appointment to such post in Force at that time.

iii) His/Her services on being a temporary Government servant shall be liable to terminate at any time by a notice in writing given either by him/her to the appointing authority or by the appointing authority to him/her.
